



2027 Canada Winter Games Cross Country Ski & Para-Nordic Technical Package



Technical Packages are a critical part of the Canada Games. They guide the selection of athletes by prescribing the age and eligibility requirements, assist the Host Society by detailing competition formats and scoring procedures, assist Provincial/Territorial (P/T) Chefs de Mission in verifying eligibility, help with budgeting by describing the number of participants permitted, advance coach certification by stating minimum requirements, and generally contribute to athlete development by identifying each National Sport Organization's (NSO) version of athletes in the "Train to Compete" phase of its Long Term Development (LTD) model, or other suitable phase of LTD as justified by the NSO.

Technical Packages are developed 36 to 24 months prior to the Canada Games primarily by NSOs, following the Canada Games Council's (CGC) [Principles that Govern Technical Packages](#). As the overall governing body of the Games, the CGC has the ultimate authority over Technical Packages, but this authority is exercised only with the knowledge and understanding of the concerned NSO.

Relevant Games stakeholders, specifically Provincial/Territorial Sport Organizations (P/TSOs) and P/T team staff, are encouraged to review the Technical Package in detail to ensure a thorough understanding. If an individual wishes to seek clarification or initiate a change to a Technical Package leading up to a Games, the request should be first directed to the NSO or the Chef de Mission. The NSO or Chef de Mission will submit the requested change or clarification to the CGC for consideration. Timelines for requesting changes to major elements of the Technical Package (i.e. team sizes, age categories, eligibility restrictions, events, competition formats) are outlined in the Principles that Govern Technical Packages. Minor corrections will be considered at almost any time, but will be increasingly difficult to achieve within six [6] months of the Games. These time frames reinforce the importance of complete understanding of the Technical Package by Games stakeholders early.

1. SPORT: CROSS COUNTRY SKI & PARA-NORDIC

2. PARTICIPANTS

2.1. Athletes

Olympic Program: 6 Men, 6 Women

Para-Nordic: 2 Men, 2 Women

All athletes must intend to compete in at least one event.

2.2. Staff

3 Coaches (1 designated for Para-Nordic)

1 Manager

1 Wax Technician

- If a team sends athletes who are women, one coach must be a woman. If a team sends athletes who are men, one coach must be a man.
- If there are no Para-Nordic athletes on the team, only 2 coaches are permitted.
- Each P/T entering one skier requiring the use of a guide will be allowed one guide position who will be accredited as an athlete. A P/T entering 2 or more skiers requiring the use of a guide will be allowed 2 guide positions who will be accredited as athletes. If required, guide alternates will be identified by Nordiq Canada's Para High-Performance Manager.

* Additional team staff positions are administered by the P/T Team. Positions must be applied for based on each P/T Team's process. For information pertaining to the process in your P/T contact your Chef de Mission.

3. CLASSIFICATION

Olympic Program: Twenty (20) years of age and under as of December 31, 2027.
Year of birth: 2007 or later.

Para-Nordic: Thirty (30) years of age and under as of December 31, 2027.
Year of birth: 1997 or later.*

*In keeping with the objective of targeting athletes within the Training to Compete (TTC) level of Long-Term Development (LTD), age exceptions may be provided to Para-Nordic athletes born prior to 1997. The CGC and Nordiq Canada recognize that an age-dependent criterion may not adequately reflect the entry of the athlete into Para-Nordic skiing due to late onset disabilities through injury or medical condition. A Province/Territory may receive an age exemption(s) only if there are no other available athletes who meet the age category. Overage athletes must meet all other eligibility restrictions as outlined in section 4.1. Athletes selected through the Para Athlete Reallocation Policy must meet the age category, no exemptions will be granted.

4. ELIGIBILITY

4.1. Athletes

All athletes must meet the eligibility regulations outlined in CGC's [Athlete Eligibility Policy](#).

OLYMPIC STREAM

Excluded from the Canada Games are:

- Senior National Team members - defined as: Athletes who have held an SR, SR1, or SR2 card at any time; and/or athletes who are part of (on the roster of) a standing Senior National Team (i.e. recognized as a Senior National Team member regardless of event participation)
- Athletes who have previously competed at any of the following events:
 - Olympic Games
 - Senior World Championships
 - World Cups (domestic World Cups not included)

All athletes must hold a valid Nordiq Canada Racing License.

PARA NORDIC

Excluded from the Canada Games are:

- Senior National Team members - defined as: Athletes who have held an SR, SR1, or SR2 card at any time; and/or athletes who are part of (on the roster of) a standing World Cup or NextGen Team (i.e. recognized as a World Cup or NextGen Team member regardless of event participation)
- Athletes who have medalled in an individual event at a FIS Para Snow Sports (FIS PSS) World Cup that holds a depth of field as defined by Nordiq Canada's criteria*
- Athletes who have finished within the top 33% of the field at the FIS PSS World Championships or Paralympic Winter Games
- Non-classified athletes: Classification by a Canadian Classifier, Canadian Blind Sports Classifier or International Classifier must take place before December 16, 2026. See Para-Nordic section of Nordiq Canada website: <https://nordiqcanada.ca/wp-content/uploads/Para-Nordic-Classification-Policy.pdf>

*Depth of field: For an individual final finish race result to be achieved, the field must include at least two (2) athletes who have fewer than 120 FIS PSS points or at least three (3) athletes who have fewer than 140 FIS PSS points on the FIS PSS overall rankings in that sport class (i.e. sit, stand, visually impaired) on the date of competition.

All competitors must hold a valid Nordiq Canada Racing License, and either a recognized Canadian or International Classification.

No athlete can be rendered ineligible within 90 days of the opening of the Games due to National Team status, carding status or competing in an excluded event

(i.e., if an athlete is granted National Team status or carding status for the first time, or competes in an excluded event after November 29, 2026, they will still be considered eligible to compete at the 2027 Canada Games).

Athletes who are in their first year of Senior National Team status may be deemed eligible on a case by case basis. Additionally, while C1 cards have been discontinued, athletes who have previously held a C1 card and who meet all other eligibility restrictions may be deemed eligible on a case by case basis. Requests must be submitted to the respective Provincial/Territorial Team Chef de Mission and approved by the Canada Games Council Sport & Games Committee.

4.2. Coaches

Head Coaches registered in the Canada Games electronic registration system must be Nordiq Canada NCCP Competition Coaching Development (CCD) certified.

Assistant Coaches registered in the Canada Games electronic registration system must be Nordiq Canada NCCP Competition Coaching Development (CCD) trained.

If a Provincial/Territorial team does not distinguish between a head coach and assistant coaches, at least one of the team's coaches must be Competition Coaching Development (CCD) certified, while the others must be at least Competition Coaching Development (CCD) trained.

Para-Nordic coaches must be Nordiq Canada NCCP Competition Coaching Development (CCD) certified in the Para Context.

Coaches must be so certified no later than 90 days prior to the opening ceremony (November 29, 2026).

Please note that "NCCP Competition-Development Certified, Not Renewed" does not qualify under the coaching standards for the 2027 Canada Winter Games.

5. COMPETITION

5.1. Events

OLYMPIC PROGRAM

MEN & WOMEN	7.5 km	Free technique; interval start (2.5 km x 3)
	1,200-1,400 m	Sprints (free technique; top 30 to quarterfinal heats)
	10 km	Classic technique; mass start
MIXED (2 men & 2 women)	4 x 5 km relay	Classic technique. Three official teams per P/T will be permitted. Unofficial teams of 2 men + 2 women may be formed with extra skiers.

Six men and six women team members may compete in all individual competitions. Start order will be determined as follows:

- Interval Start Races – grouped by Canada Points (Distance) and randomly seeded within groups; starting order of the groups to be decided by the Jury
- Sprint Qualification – order by Canada Points (Sprint) i.e. best start first
- Mass Start – order by Canada Points (Distance) i.e. best in first position
- Mixed Gender Relay – Start order by combined Distance points of team members. Each P/T will be eligible to position one team in Group A. P/T's second team will be positioned in Group B. P/T's third team will be positioned in Group C. Among all Group A teams, the P/T team with the highest total Distance points will start as number one, the P/T team with the second highest total points will start as number two **on the grid** and so on until all Group A P/T-designated teams are placed. The positioning of P/T teams in Group B and Group C will follow the same protocol. Unofficial teams will be positioned by combined points at the back of the start grid. In the case of teams having equal total points, the team with the highest point-holder starts ahead of the other. Skier order will be as follows: Leg 1 - men, Leg 2 - women, Leg 3 - men, Leg 4 - women.
 - Para-Nordic Standing skiers may be included in a relay team composition. In this case, the team will be considered an official team as designated by the P/T coaches and be seeded at the end of the respective A, B or C groups.

PARA-NORDIC

Para-Nordic competitions will be run as two categories: sitting (sit-skiing class) and standing (visually impaired and standing classes, a combined category).

In the standing category, athletes classified as visually impaired will be compared to standing classified athletes to determine final race results in both men’s and women’s events by applying percentage formulas (as per FIS PSS rules) correlating standing skiers’ performances with visually impaired skiers’ performances. In the sitting category, results will be determined by applying percentage formulas (as per FIS PSS rules) specific to the athletes’ disability classes.

In that respect, race courses used for Para-Nordic events will be designed (slopes, turns, etc.) in order to be fair for all Para-Nordic athletes within each of the three categories.

All four athletes may compete in all Para-Nordic competitions.

*Para-Nordic sit-skiers require as level a surface side to side (full trail, not just tracks) as possible to prevent side slipping and properly banked corners on downhills.

5.2. Weather Protocol

6. TIE BREAKING RULES - COMPETITION

If two or more competitors have the same time in the Interval Start Races, they shall have the same placing on the final list. If titles or medals are to be distributed, all those tied shall receive the same title and/or medal.

7. REGISTRATION & EVENT ENTRIES

7.1. Canada Games Council Registration Deadline

All participants (athletes, coaches, managers and additional team staff) must be registered in the Canada Games electronic registration system no later than 30 days prior to the Opening Ceremony (January 28, 2027).

7.2. Event Entry Deadline

Nordiq Canada requires event entries and license numbers to be submitted via the Sports Registration and Timing system no later than 30 days prior to the Opening Ceremony (January 28, 2027). Event entries for each athlete will be confirmed at the Coach/Manager meeting held prior to the first event.

8. SPORT SCORING POINTS

Sport scoring points are a tool used to determine the performance of a P/T Team across all events within a sport. At the conclusion of an event, sport scoring points will be awarded using the following criteria:

8.1. Individual Events

- Athletes will be ranked from first through last place in Olympic Program events **including the sprint race based on the final results (ICR 325.5.2.4)**. Para-Nordic positions will be determined by adjusting real time by the percentage for each athlete according to their classification.
- For Olympic Program events, each Province/Territory's four (4) best positions will count for sport scoring points. For Para-Nordic events, each Province/Territory's best position will count for sport scoring points. Other scores are omitted.
- If an athlete does not finish or is disqualified, the athlete will not receive sport scoring points
- If there is a tie, points will be shared equally between competitors (i.e. If two athletes are tied for first then each competitor would receive 97.5 points $[(100+95)/2]$ and 3rd place points would be awarded to the next finisher)
- Each event will be scored separately
- Sport scoring points for individual Olympic Program and Para-Nordic events will be awarded based on the charts below:

For Provincial/Territorial teams that have received additional athletes through the CGC's [Para Athlete Reallocation Policy](#), coaches will be required to select four (4) Para-Nordic athletes (2 per gender) whose results will count towards sport scoring for the entirety of the Games. The names of the four (4) athletes whose results will count towards sport scoring must be provided to the Competition Secretary at the first TCM prior to the start of the Games.

For sport scoring purposes only, the final rank of non-scoring para skiers (skiers designated as not eligible for sport scoring as determined by the Provincial/Territorial coaches) will not be considered and the remaining athletes will be re-ranked to provide the official sport scoring results. Medals will be handed out in order of finish and will include non-scoring para skiers (as stated below in section 10).

For example, for Para-Nordic races the sport scoring would be as follows, assuming Athlete B is a non-scoring para-nordic skier:

- Athlete A finishes 1st and receives 50 points – 1st place points
- Athlete B finishes 2nd and receives 0 points – no points
- Athlete C finishes 3rd and receives 45 points – 2nd place points
- Athlete D finishes 4th and receives 40 points – 3rd place points

Athlete B would be awarded the silver medal. Athlete C would be awarded the bronze medal.

8.2. Relay Events:

In the Relay events there are 26 scoring positions, with points allocated for 1st through 26th. Only the top two relay teams (based on final placing) per P/T will be allocated points. Only teams that complete all legs of the relay will be allocated points. Unofficial teams are not eligible for points or medals. In the case where unofficial teams or a P/T's third team finish ahead of official teams, the final rank of official teams for scoring will be advanced as if the unofficial teams/third teams were not in the race.

9. FLAG POINTS

Games to Games performance by a P/T Team at the Canada Games is measured by accumulated Flag Points. Every P/T Team is awarded Flag Points for its ranked performance in each sport in which it competes.

In Cross Country Ski & Para-Nordic, Flag Points will be awarded together for women's and men's events based on the total of sport scoring points awarded.

After ranking the P/T Teams from first to last, and after any ties have been resolved as detailed in Section 10 (Tie Breaking Rules - Flag Points), Flag Points will be awarded as follows:

10. TIE BREAKING RULES - FLAG POINTS

- If a tie occurs in the final Provincial/Territorial team standings, the Province/Territory with the greater number of first places will be assigned the higher rank.
- If the tie persists, the procedure is repeated for second places.
- If necessary, the procedure is repeated for third places, then fourth places, etc.
- If the tie persists, the Province/Territory with the higher standing in the last event completed will be assigned the higher rank.
- If necessary, the procedure will be repeated for the second last event completed, and the third last, etc.

NOTE: When a triple tie occurs and is only partially resolved, the remaining ties will be resolved by returning to priority #1 and proceeding through the order again.

11. MEDALS

- 11.1. The Canada Games will award medals to athletes only. Gold, silver and bronze medals will be presented for each event.
- 11.2. Gold: 22 Silver: 22 Bronze: 22
- 11.3. If an athlete with a visual impairment medals, a medal is also to be awarded to that athlete's Guide.
- 11.4. Athletes selected to compete in the Para-Nordic events through the Para Athlete Reallocation Policy will be eligible to win medals.

12. COMPETITION UNIFORM

Provincial/Territorial team colours must be worn. Additional information on each Provincial/Territorial team's colours can be found in Appendix C of the CGC's [P/T Team Uniform and Sponsorship Policy](#).

The Host Society will supply competitor bibs for the races, including training and Guide bibs for Para-Nordic skiers.

13. EQUIPMENT

Nordiq Canada rules will govern the competition.

Not permitted:

- All fluoro glide and fluoro kick wax.
 - High fluoro (HF), medium fluoro (MF), or low fluoro (LF) glide wax, including HF, MF, or any fluoro powders, pucks, blocks and liquids.
 - Fluoro cold weather powder additives and hardeners.
 - Fluoro grip hardeners.

14. PROTEST & APPEALS

14.1. Canada Games Council Protest Policy & Appeal Policy

Appeals relating to a decision made based on this Technical Package or any decisions made by the CGC will be made in accordance with the CGC's [Appeal Policy](#).

Protests relating to disputes between and among Provincial/Territorial Teams as it relates to the CGC Policies, Procedures and Principles that Govern Technical Packages will be made in accordance with the CGC's [Protest Policy](#).

14.2. Competition Protests

Protest and Appeals guidelines can be found in Section 361 of the 2026 [ICR-CRR](#) Rules and Precisions found in the Document Section on the Nordiq Canada website.

15. ANTI-DOPING

The CGC adopts the Canadian Anti-Doping Program (CADP) Covenant as a fundamental commitment to engage in a cooperative and collaborative effort to eliminate doping in sport and to support harmonized, coordinated and effective anti-doping measures in Canada. Any Canada Games participant (athlete, coach, manager, technical support, or other person) found to have committed an anti-doping rule violation at the Canada Games (as determined pursuant to the CADP) will be subject to all of the penalties and consequences, as outlined in the [Canadian Anti-Doping Program](#).

The following Performance Guidelines have been established by the respective NSO, at the request of the CGC and the Federal-Provincial/Territorial Sport Committee (FPTSC), to reflect the expected training and/or performance parameters of a typical Canada Games athlete in the Training to Compete (T2C) phase of LTD. These Performance Guidelines have been developed as a tool for P/T teams to use at their discretion in the training and selection of their Canada Games teams.
